**Ramblers' Association, Buckinghamshire, Milton Keynes and West Middlesex Area  
Minutes of the Annual General Meeting held at 2.00 pm on Saturday 14 February 2009  
in the White Hill Centre, Chesham, Buckinghamshire**

John Esslemont in the chair and 52 members signed the attendance list.

John Esslemont introduced the Annual General Meeting and welcomed those present including the guest speaker – Tom Franklin, Ramblers' Association Chief Executive. John introduced the current Area officers.

John Elfes reminded members of the 'house-keeping' arrangements such as fire drill, toilets, etc.

1. Apologies for absence were received from Alec Fleming, John Newman, Adele Brazier, Doris Bonwitt, Mike Roe, Donald MacCallum, Buckingham & District Walking Group, John Frankland.

2. The Minutes of the AGM held on Saturday 9 February 2008 were signed as a correct record.

3. Matters arising from the minutes

item 6: our motion was carried at GC. The following progress report was issued in October:

"A survey on the Ramblers' image was printed in the summer edition of Walk Magazine and was also available online. More than 4000 responses were received. Focus groups have also been conducted with non-members and volunteers. Most recently, Areas have been consulted on issues to do with the Board of Trustees, the 75th Anniversary and the draft Code of Conduct for volunteers, trustees and staff."

[The Chairman considers that only the image survey is really relevant to our motion, which was concerned with opinion among the membership at large, as opposed to non-members, volunteers, or Area committees.]

item 9(b): the letter to Affiliated Local Organisations went out with the Annual Report; two out of eleven have replied, both declining to appoint representatives

item 10: Janet Mitchell was, unfortunately, unable to act as Independent Examiner due to unforeseen circumstances, so the Treasurer (with the Chairman's agreement) arranged for Keith Yates, who is also the Independent Examiner for Milton Keynes Group, to do the job instead. The Area Executive Committee approved the change at its last meeting.

4. The Annual Report and Accounts

(a) Chairman's Report

The Chairman thanked all contributors to the Annual Report and, in particular, John Frankland for help with printing and distribution. He appealed for a volunteer to edit the report next year.

He had, to date, received 125 responses to the questionnaire on the report. There seemed to be a fair measure of support for the view that our present practice of sending the report to all members is wasteful. Around 15% of the respondents found the report of no interest whatsoever but that had to be set against a similar proportion who currently take some interest in the report but would not make any positive effort to get hold of it.

A modified version of the Report with, for Data Protection reasons, contact details of individuals removed, had been placed on the Area web site. He was concerned lest Path Checkers might not wish even their names published on the Internet and asked to be notified of any objections.

***Asked for show of hands on whether anybody has looked at it online and what they thought.*** Only a few people responded.

(b) Secretary's Report

No comments or questions. The Secretary thanked John Esslemont for his support.

(c) Membership Secretary's Report

John Wainwright noted the decline in membership over the previous year although he commented that this year's figures may not be totally reliable due to work at RA Central Office on a new membership computer system. He thanked Group membership secretaries for their work. John Esslemont

congratulated Aylesbury on achieving a good increase in membership for the second time in three years.

(d) Footpath Secretary's Report

Kate Ashbrook thanked Group Footpath secretaries and Path Checkers. Kate welcomed the news that the work of the Rights of Way team at BCC would not be contracted out this year and that the budget would remain the same. John Esslemont thanked David Bradnack and Roy Johnson for recent work on notes for Path Checkers.

Kate was asked to comment on the recent BVPI statistics which said that 78% of paths in Bucks were in a 'satisfactory' condition. Kate was asked if 'problem' paths within her report were 'inaccessible'. Kate replied that missing signs, stiles, poor surface conditions, made many paths inaccessible for a lot of people who wanted to walk in the countryside.

Another question to Kate concerned 'permissive' bridleways. Kate replied that landowners can give permission for horse riders to ride on paths over their land. It can be difficult to know the circumstances but if the surface of the path has been affected then this can be reported to BCC Rights of Way team.

(e) Treasurer's Report and Accounts

John Esslemont introduced the accounts in the absence of John Frankland. John commented that responses to the Annual Report questionnaire suggested little interest in the accounts; however it was essential that they should be made available to members for scrutiny.

John noted that we have *finally* paid BCC for Donate-a-Gate (David Bradnack said we had received a letter of thanks from BCC).

He thanked John Frankland, for the large amount of work in a short period of preparation of accounts and budget and thanked Keith Yates for taking over as Independent Examiner on short notice and to tight timescale.

The meeting was asked to accept the accounts. (*Proposed*: Tom Berry, *Seconded* by Martin Harris).

Accepted by all present. It was noted that the Independent Examiner's statement mentioned 'year ending 30 September 2007'. This should have said '2008'. John Esslemont would draw this to the attention of the Area Treasurer.

(f) Area Access Officer's report

John Elfes updated the meeting on the current position with regard to the access land at Grays Lane Bank. John said that the landowner had stated his intention to claim that it is parkland or garden and therefore excepted. This had meant that BCC could not go ahead with installing access gates and had returned the money for this to Natural England. However, from May the land could be legally accessed under the legislation. A comment was made that a small event could be arranged to draw attention to the situation. John mentioned that a sum of money £5713 -50 was available and earmarked to be spent on improving access to five sites.

He mentioned the Quiet Lanes project and reminded members that we had used two of these tracks – being claimed as byways rather than bridleways - during the morning walk.

(g) Press Officer's Report

Kate commented that she put out occasional press releases but was unable to say how much these were taken up by local papers in Bucks. Members present were asked how many took a local paper and if they had seen mention of the ramblers activities. It was suggested that members could send in cuttings to Kate. Kate said she would issue a press release after the meeting.

(h) News Editor's Report

There were no comments or questions.

(i) Walks Editor's Report

David reported how much he enjoyed walking over the routes and drew attention to the need to consider continuing the work in the future. He appealed for volunteers to get in touch with him.

(k) Local Group Reports

There were no comments or suggestions.

John Esslemont commented that a report should have been asked for from our representatives on the RA's London forum. A report would appear next year.

7. Election of Executive Committee Members not appointed by Local Groups:

(a) Representatives of Individual Members

Mike Roe, David Barnard, Hugh Westacott, and Oliver Statham (*Proposed*: David Bradnack, *Seconded*: Kate Ashbrook) were elected.

(b) There were no nominations for representatives of Local Organisations affiliated to the RA.

8. Appointment of Independent Examiner.

Keith Yates (*Proposed*: John Esslemont, *Seconded*: John Shipley) was elected Independent Examiner.

9. Appointment of representatives to the RA General Council 2009.

John Esslemont gave a brief explanation. The Area is entitled to send two official Area representatives, entitled to speak and vote during formal GC sessions. It has also been Area policy to send up to two visitors at Area expense. Kate Ashbrook and John Esslemont are members of General Council in other capacities.

*Proposed*: John Elfes, *Seconded*: David Bradnack and agreed by those present at the AGM that the two representatives would be as follows: John Wainwright and Tom Berry. It was noted that the committee had agreed that Chas Pickett should attend as a visitor.

10. Any other business

The Chairman reported that the 25<sup>th</sup> Anniversary of the formation of the Area on the subdivision of the former Southern Area would be this year. Also, the 75<sup>th</sup> Anniversary of the Ramblers' Association would be 2010. Ideas on how to celebrate these anniversaries were requested. Tom Franklin said the latter had been discussed at the Board of Trustees and proposals would be forthcoming.

A member raised the topic of Walkers Welcome saying that this would be a good initiative for a town in our Area. The Princes Risborough walking festival was mentioned. Kate Ashbrook agreed to get details.

11. After the interval Kate Ashbrook introduced the guest speaker, Tom Franklin, Chief Executive of the Ramblers' Association, who gave a very good talk outlining aspects of his work, the issues facing the Ramblers' Association at this time, and the direction most likely to achieve success. Tom talked about the present financial climate – the recession – and how this might be an opportunity for us. People's concerns over health, finance, climate change were leading to more interest in walking. It was important for the RA to have the right appeal to members.

Tom recognised that a concern of members currently involved in RA work was the difficulty in getting members to volunteer. Overall RA membership had fallen slightly over the last 5 years and the membership was getting older. It was important to see how people view the ramblers from outside. Recognise the increase in non RA walking clubs, and, the availability of walking information from the web.

Last year the RA General Council voted for a new direction 'Fresh Air, Firm Ground'. Four key things include: a good quality environment for people to walk in; offering a variety of walking experiences to get people to walk; get walking, keep walking – introducing people to the benefits of walking; improving the way we work. Building on the success we have already achieved.

Tom ended with a quote from Charles Darwin 'It is not the strongest of the species that survives. It is the one most adaptable to change'

Tom took questions on the following: inaccessible paths (replied that we have a unique path network and this needs to be accessible to the walking abilities of 'normal' people); democracy within the RA – do people care? (answered from the floor – mostly people do not care. The RA should let the Groups get on with what they want to do!); image – will you be deciding what members must wear? (no); RSPB – has a lot more members than the RA – why successful?(several reasons – suggestion that they have a strong focus on younger members. The RA is looking at this); incentives for introducing new members? (variety of ideas are being considered); balancing act for the RA difficult? (charity, campaigning, membership all demonstrate the RA's being there for the public good).

After a question and answer session the Chairman closed the meeting by thanking Tom Franklin for his talk, John Elfes for making arrangements for the meeting, David and Joyce Wills for leading the morning's walk, Jean Bamford and her team – Madeleine Moody, Peggy Mills and Jean Staveley - for doing the refreshments, and all those volunteers within the Area who give their time to the R.A.

## Area Annual Report 1 October 2008 - 30 September 2009

### Chairman's Report

The year under report has seen the Association nationally facing financial crisis, with the Board of Trustees being forced to take drastic economy measures. This has led to considerable unrest at various levels (see the Vice Chairman's report, below, for further details). My personal belief is that the Board has acted appropriately in difficult circumstances. While I might agree with some of the complaints of the dissenters I feel that some of their fears for the future are unjustified, and some of their aims unwise.

One of the economy measures has been a reduction in funding available for Areas and Groups for the current year. We have managed to accommodate this by budgeting for reduced reserves, but such an approach cannot be sustained in future years. If Groups are to maintain their programmes of walks and other activities, which I regard as essential to the Association's wellbeing, increased funding **must** be found for 2010-2011.

On a lighter note, I set myself the task during the year of assessing the adequacy of signage on access land in southern Buckinghamshire, and found it distinctly deficient. I have reported defects to the County Council. The access rights we were given by the Countryside and Rights of Way Act will only give full benefit if the public know *what* they can do, and *where* they can do it.

I usually end this report by thanking all those who contribute voluntary work to Ramblers in whatever capacity and whatever level. I do so again but, this year, would particularly single out the Area and Group treasurers, who have had to cope with additional work in difficult circumstances. It has also been another difficult year for the Area and Group Membership Secretaries, with continuing problems with the Central Office computer system; they too deserve special thanks.

## **Vice Chairman's Report**

In August 2009 three officers of the West Riding Area sent out a circular inviting members to a "Concerned Ramblers" meeting in Leeds on 26<sup>th</sup> September. I attended this meeting as an individual member, not as an Area representative. The meeting was attended by over ninety members from virtually all Areas.

The main theme was general dissatisfaction with the performance of both the Board of Trustees and the management, and with the handling of the financial situation in particular. There was general agreement on this. There was criticism of the Chief Executive, Tom Franklin, some angry and some more measured, and some calls for his dismissal. The Board of Trustees and its Chairman were also heavily criticised. The rebranding exercise was held up as an example of waste, and the CRM (the troubled new membership records system) as proof both of waste and incompetence.

There much emphasis on re-focussing Ramblers' policies and resources on Rights of Way and Access, with the Ramblers' being less involved in national initiatives to promote walking. This view was based on the perceived shift of resources away from Rights of Way in Head Office reorganisation, the decision to abandon funding for legal action on Rights of Way, and scepticism about Get Walking Keep Walking being truly self financing. There were discussions on accountability, and whether the requirements of charitable status were being properly interpreted by the Board.

The meeting rejected a call for an Extraordinary General Meeting of General Council.

A list of aims was agreed-

Immediate Review of the present RA strategy document "Fresh Air Firm Ground"

Rights of Way and Access to be major RA focus

Legal Work to be resumed immediately

Immediate Review of all Rights of Way policy

Immediate Review of Promoting Walking

Details of Substantial Financial Transactions over last two years to be made available

Open Democratic Style of Government

Review of the RA's interpretation of its requirements as a charity

A steering group was formed and I was nominated to it. At the time of writing the group is working on a series of motions to put to General Council 2010.

Overall, for me it did not have the same 'bite' as the previous year in Winchester where the future of the RA - pre credit crunch - was debated and decided. Also, the bar facilities were much poorer! However, later events have shown with what wisdom Tom Franklin 'warned' that the RA could not rely on its past successes and needed to look to the future if it was to remain at the forefront of walking in this country. Looking round I did feel that the RA has some work to do to be truly representative of our society today. A good weekend and very worthwhile so why not consider representing us next year?

## Treasurer's Report

The accounts are set out to show the amounts spent on the four main charitable objectives of the RA, namely promoting walking, promoting the integrity of the footpath network, securing greater access on foot to the countryside and protecting the outdoor environment.

The accounts and annual return of the Area to Central Office (CO) have been prepared on an accruals basis. Under accruals accounting income and expenditure are recorded in the period to which they relate. Accruals accounting is used to avoid distorting accounts and masking the true asset level.

Area was funded from CO via the budgeting system. The budgeted sum of £8,365<sup>#</sup> was requested from CO and agreed, (<sup>#</sup> this figure was adjusted by CO to take account of reduced distribution costs of South East Walker (SEW) via CO). We only drew £7,280 of the funding from CO because of the reduced cost of our Annual Report: £589 compared with £1,617 for the previous year. Area ended this year with reserves of £3,245 which is virtually as targeted. Groups were provided £4,376 of funding by Area; their aggregated end of year reserves stands at £3,850 which is £536 lower than the previous year. Nevertheless a few Groups have reserve levels that look a bit too healthy and may draw the attention of the CO Finance Team when the review of Area and Group reserves is conducted during January/February 2010.

The year was overshadowed by the financial crisis the RA is suffering:

- The budget and funds required from CO are normally determined from the previous year's income/expenditure and other information to hand at the start of each financial year.
- CO required Area to reduce its funding request for 2009/10 by 25% of that covered by this report.
- As a result for the year to 30 September 2010 the sum of £6,274\* has been request from CO, (\* 75% of this year's requested £8,365 of funding).
- Area has been able to accommodate this reduced funding by the realised saving in production of the SEW magazine; electronic distribution of the Annual Report adopted as the norm; reduced funding of Groups mainly by utilising about £550 from their reserves and utilising £470 from Area reserves.
- Area's Group Funding Formula (GFF) has now been suspended and isn't likely to be resurrected now that CO have introduced their budgetary funding system across all Areas and Groups.
- This entailed substantial amount of work by the Area Treasurer, Chairman and Group Treasurers and their colleagues.
- CO would do well to remember that first and foremost we are volunteers, who normally give our time willingly and freely.

Buckinghamshire County Council eventually invoiced us for the £2,000 and work completed on the "Donate a Gate" project which was shown as a creditor in last year's accounts.

Area received 11 shares in Ramblers' Association Services Ltd in lieu of interest; making a total holding of 267 shares, valued at £1 each.

Up to date accounts are circulated to Committee Members prior to each Committee Meeting for scrutiny and subsequent approval at the Committee Meeting. Two signatories are required to make any withdrawals by cheque or bank draft from the Area's bank account. Current signatories are David Bradnack, John Elfes, John Esslemont and John Frankland.

I would like to thank all the Group Treasurers and their Auditors for their hard work in getting their end of year accounts and annual returns completed so duteously. I would also like thank those Group Treasurers that submitted budgets for the next financial year to 30 September 2009; I anticipate more doing so in subsequent years.

Finally I thank Keith Yates, our Independent Examiner, for all his invaluable help in scrutinising our accounts once again.

There has been a small decrease in membership in the Area. Impressive growth has occurred in the Chilterns Weekend Walkers and Milton Keynes & District groups. However, this has been offset by significant losses in the Hillingdon and West London groups.

A great deal of work has taken place in Central Office to deal with the problems caused by the transition to the CRM system. There has been an improvement in the processing of membership subscriptions. However, the monthly membership reports sent to membership secretaries still leave much to be desired. The new and improved monthly membership reports promised for August did not materialise.

During the year, I commenced electronic distribution of monthly membership reports to Group Membership Secretaries in the Area. They now receive the reports much sooner than they did by post and there has been a significant reduction of Area membership expenses. All but one group are accepting the reports in this way.

## Footpath Secretary's Report

Our volunteer path checkers walked many miles, checking the paths in their parishes and reporting problems to the highway authorities. The results were collated by the path check coordinator for each district and borough.

The results show that for Aylesbury Vale District we checked 64 out of 111 parishes and 1509 out of 2180 paths, walking 1022 km and reporting 504 problems. This took at least 861 volunteer hours, where time estimates were given. The most common problems were overgrowth, poor or missing stiles or gates, missing signposts and cropping. In South Bucks District seven of the 12 parishes were checked and 16 problems reported, while in Wycombe District we received returns for 24 parishes and, although not all the paths were checked, there were 61 problems. In Chiltern District 11 parishes out of 19 were checked, and 71 problems were found in 399kms of paths walked.

In Milton Keynes, 26 of 47 parishes (403 paths) were checked, and 218 problems were found. The most common ones were missing waymarks, missing signposts, cropping and poor gates and stiles.

In Brent, one volunteer, John Mann, checked 104 recorded paths and a further 54 unnumbered ones, reporting 111 problems on 76 of the numbered paths; missing signposts were the most common. In Harrow, Graham Wright checked 83 paths, finding 41 problems, again mostly missing signposts. In Hillingdon, Mike Meehan led a team of volunteers who checked 374 paths, 11 of them blocked, four difficult, ten unclear, and 98 missing a signpost at one or both ends. However, 191 were improved on last year.

There were 26 path-change proposals during the year. We objected to six and did not object to 20. We were able to amend some to make them acceptable to us and three applications were withdrawn following our objections. We did not comment on most consultations on applications to alter the status of routes because we had no evidence to offer.

At the end of 2008 we learnt that Bucks County Council was threatening to contract-out its rights-of-way work in 2009-10. We lobbied councillors to resist this as the experience of our colleagues in the Northamptonshire Ramblers is that it is detrimental to the rights-of-way network. We were relieved when the council decided not to follow this route. However, in the autumn of 2009 we learnt that the rights-of-way budget was seriously threatened, due to cuts all round, and we encouraged our members to write to their councillors, arguing for the value of an investment in public paths.

Bucks County Council's rights-of-way liaison groups for the north and south met twice during the year and we were represented at all four meetings. David Bradnack did some further excellent work in identifying anomalies on the definitive map and suggesting improvements to the county council.

I should like to thank, in particular, Roy Johnson, Donald MacCallum, John Elfes, Martin Harris, Mike Meehan, Mike Roe, Jeff Smith, John Mann and Graham Wright for all their help in analysing path check, corresponding with path checkers, checking their own parishes, and generally giving me welcome support and assistance. We are indebted to all our path checkers for their vigilance on paths in their patch and for their advice on path changes. But we still have vacancies, so please look at the list of vacant parishes in this report and volunteer if you can (perhaps on a one-off basis first). If someone is occupying your chosen parish please let us know, as there is always scope for job-sharing.

## **Access Officer's Report**

It seems impossible, but it is nearly ten years since the Countryside and Rights of Way Act (CRoW) became law, and Open Access was introduced. It is therefore time for the promised decadal review, where we hope to resolve some of the difficulties and inconsistencies of the original Act. In this area the main aim will be to refine the definition of downland so that many areas which meet a commonsense definition of down can be added to the access maps.

### **Open Access: Grays Lane Banks**

The saga has taken a further turn. Despite the Planning Inspector's decision, reported last year, and the reinstatement of this piece of land to the Conclusive Map, the owner has refused to cooperate with Bucks County Council (BCC) on previously agreed access points to the land, and no work has been carried out. The owner is now claiming that the area is his garden, or alternatively parkland. The Bucks Local Access Forum wrote to BCC, urging them to take all necessary steps to gain access. BCC is taking legal advice on how to proceed, but there are very tight limits on legal expenditure at present.

### **Coastal Access:**

At the time of writing, the Marine Bill, which includes the proposal for Coastal Access, is on the point of receiving royal assent, and subsequent implementation.

### **Bucks Rights of Way Improvement Plan**

Actual projects are now being considered, mostly based on improving the bridleway network. We still need suggestions for improvements to the footpath network from Groups, Pathcheckers and individual members.

### **Local Access Forums:**

**General:** I reported last year on some progress towards the establishment of an England Access Forum (EAF), and a Regional structure, which would provide a means of liaison between Forums, and with Natural England. Progress remains slow. The South East region LAF has met once this year and the second meeting is overdue at the time of writing. There has been little information from either the EAF or Natural England. There is still no progress on setting up a national website, which remains the preferred (and cheapest) option.

**Buckinghamshire:** The forum continues to deal with all Access matters and with strategic Rights of Way issues. There have again been no applications for long term **closures** in the last twelve months. **BCC budgets** have been squeezed yet again, the money for “on the ground” works by 25% (identical to last year’s proposals). The government funded **Access Management Grant** has reappeared, but in a much reduced form, and bids must now be made for individual projects. The proposed **Parish Conference** has been deferred yet again for financial reasons. There has been no progress on **Quiet Lanes**. There has been a marked increase in the number of applications for new **Village Greens**. BCC is considering how to extend the Chiltern Society **Donate-a-Gate** scheme to Aylesbury Vale. They are not proposing matched funding, however, and are looking for someone to run the scheme on a volunteer basis. BCC is still in the process of **Outsourcing** a number of its departments. Last year’s BCC cabinet decision to exclude Rights of Way and Access from the proposals was welcome, but the threat is still there. In short, the outlook is gloomy, and there is no prospect at all of improvement in the financial position.

**Milton Keynes:** I shall give a verbal report on the Milton Keynes Local Access Forum at the AGM.

## Walks Editor's Report

We still have very little idea how many people are using our routes, though I met someone from outside our Area who said he had enjoyed several, and I know that a Group from another Area use some for their Group walks.

We have statistics for the number of times walks descriptions have been opened and read. In total this averages more than 5,000 a month. Of those, it is not known how many were because someone wanted a walk in that location, and how many arose from a Google search for something that just happened to be mentioned in the walks description.

Of the fully described walks, the ten that were most looked at were the walks from Denham, Aylesbury (to Wendover), Gerrards Cross, Wolverton, Amersham, Marlow, Pinner, West Wycombe, Haddenham and Lane End ..... and the three least were from: West Drayton, Little Kimble (to Saunderton) and Saunderton.

We might tentatively conclude that people are interested in walks routes throughout our territory, not just in the tourist honey pots.

We also know that there were an average of over 2,000 downloads a month, indicating that people were sufficiently interested in what we have said about a route to want to save it and/or print it. We can assume that if people are going to walk the route they will print or copy it, but not necessarily the reverse.

The item most often downloaded was the Map Reading Exercise, followed by the Thame Valley DIY route. Of the fully described routes, the top ten were: Aylesbury (to Wendover), Northwood, Oving, Pinner, Leighton Buzzard, West Wycombe, Wendover, Wolverton, Marlow and Beaconsfield ... .. and the bottom three: Taplow, Burnham (to Langley) and Monks Risborough (ignoring the West Ruislip walk, which we had to close because of pipeline works).

Also of interest is the ratio of downloads to readings. All the DIY walks were at or near the top of the list. Of the described routes, the top ten were: West Drayton, Leighton Buzzard, Saunderton, Northwood, Little Kimble (to Saunderton), Steeple Claydon, Oving, Tring, Monks Risborough and Pinner ... .. and the bottom three: Haddenham, Burnham (to Langley), and Denham.

The West Drayton walk is undoubtedly a nice walk – otherwise it would not be on the website – but it is not obvious why it is top of the list. I had considered reversing it, because of better refreshment opportunities at the West Drayton end, but will now probably not do so. A year or two ago the Saunderton walk was new and the Leighton Buzzard one was extended. The Oving walk was reversed this year, previously starting at Granborough.

It is startling that the Denham walk was top of the first list and bottom of the third. Part of the trouble may have been the dual carriageway crossing, which we have now avoided. It is unfortunate that the pub about half way on the Haddenham walk has very limited opening hours – but it does a nice Sunday roast. Both these walks descriptions include a number of alternatives, which may be confusing and a disincentive, though we have recently eliminated some in the Denham walk. We admit to more road walking on the Burnham walk than we would ideally like.

We have changed the Chesham walk to eliminate some road walking, and made minor tweaks to many of the others. All routes have been checked within about a year, by Howard Cave, Donald MacCallum or me, and our thanks are again due to Howard for maintaining the website. As I said in my last report, with increasing age I would welcome the opportunity to share some of the checking of routes in the north and the south-west of our area.

The Forum's progress and lack of funding was discussed at the 25th August Area committee meeting and the Area representatives at the October meeting of the Forum were advised to suggest that the activities of the Forum should be limited until such time as adequate financial support could be offered by Central Office.
